3:00 pm - 4:30 pm: Addressing Wildfire Resiliency in CEQA Documents - AICP: 1.5 | MCLE: 1.0 The fourth and final panel of the day will address a pathway for considering wildfire resiliency, in conjunction with the analysis of fire hazards in documents prepared pursuant to the California Environmental Quality Act (CEQA). Particular emphasis will be placed on how best to meet the standard for an information document, considering recent cases limiting CEQA analysis to the effects of the project on the environment, rather than the effects of the environment on the project. An important aspect of the conversation about wildfire resiliency and CEQA is streamlining opportunities for environmental review approaches to implement fuel reducing vegetation treatments, fuel breaks, evacuation routes, and other features of making communities more wildfire safe. The streamlining discussion will highlight recent efforts undertaken by the Board of Forestry and Fire Protection's California Vegetation Treatment Program EIR and other regional-scale environmental reviews in Tahoe and the Sierra Nevada.
